A. RESULTS OF 182 DAYS TREASURY BILLS ISSUE NO. 1955 VALUE DATED

22/10/2012

This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 4 Billion. The total number of bids received was 137 amounting to Kshs. 6.2 Billion representing a subscription of 154%. The market weighted average rate was 10.689% and the weighted average of accepted bids which will be applied for non-competitive bids was 10.484% up from 10.307% in the previous auction. The other auction statistics are summarised in the table below.

Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 24th October 2012 for 182 and Thursday 25th October 2012 for 91 days Treasury Bills respectively. Payments exceeding Kshs. 1 Million must be made by electronic tranfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Monday 29th October 2012 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Investor's Name, Reference Number and Portfolio Account Number, Please remit the payments to your Virtual Account at Central Bank of Kenya.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
