A. RESULTS OF 182 DAYS TREASURY BILLS ISSUE NO. 1892 VALUE DATED

27/06/2011

This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 2.5 Billion. The total number of bids received was 97 amounting to Kshs 3.53 Billion, representing an oversubscription of 141%. Consequently, the weighted average of accepted bids, which will be applied for non-competitive declined by 5.2 basis points to 9.854% from 9.906% recorded in the previous auction. The other auction statistics are summarised in the table below.

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
