This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 3 Billion. The total number of bids received was 44 amounting to Kshs 2.1 Billion, representing a subscription of $69 \%$. Consequently, the weighted average rate of accepted bids, which will be applied for non-competitive rose to $16.543 \%$ from $16.471 \%$ recorded in the previous auction. The other auction statistics are summarised in the table below.
