A. RESULTS OF 91 DAYS TREASURY BILLS ISSUE NO. 1921 VALUE DATED

17/10/2011

This week the Central Bank of Kenya offered 91 day Treasury Bills for a total of Kshs 4 Billion. The total number of bids received was 459 amounting to Kshs. 4.2 Billion, representing a subscription of 104%. Bids accepted amounted to Kshs 2 Billion. The market weighted average rate was 16.795%, while the weighted average rate of accepted bids, which will be applied for non-competitive bids, was 14.997% up from 14.836% in the previous auction. The other auction statistics are summarised in the table below.

Bids must be submitted using the specified format and must reach the Central Bank (HQ or Branch) by 2.00 p.m. on Wednesday, 19th October 2011 for both the 91 day and 182 day Treasury Bills. Payments above Kshs. 1 Million must be made by electronic tranfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Monday 24th October 2011 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS account No., and include 'Government Treasury Bills Suspense A/c no. 01-070-0001' when using RTGS.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
