This week the Central Bank of Kenya offered 91 day Treasury Bills for a total of Kshs 4 Billion. The total number of bids received was 463 amounting to Kshs. 9.89 Billion, representing a subscription of $247 \%$. Bids accepted amounted to Kshs 7.04 Billion. The market weighted average rate was $20.882 \%$, while the weighted average rate of accepted bids, which will be applied for non-competitive bids, was $\mathbf{2 0 . 7 6 9 \%}$ down from $\mathbf{2 0 . 7 9 9 \%}$ in the previous auction.
