This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 2.5 Billion. The total number of bids received was 65 amounting to Kshs 1.74 Billion, representing a subscription of 70%. Bids accepted amounted to Ksh.1.50 Billion. The market weighted average rate was 8.623% while the weighted average rate of accepted bids, which will be applied for non-competitive bids was 8.450% down from 8.065% recorded in the previous auction.
