A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2130/182 & 2056/364 DATED

29/02/2016

This week the Central Bank of Kenya offered 182 and 364 Days Treasury Bills for a total of Kshs. 12 Billion. The total number of bids received was 146 amounting to Kshs. 9.79 Billion representing 163.10% subscription and 209 bids amounting to Kshs. 7.35 Billion representing 122.55% subscription for 182 and 364 days, respectively. Bids accepted amounted to Kshs.5.16 Billion for 182 days and Kshs. 7.34 Billion for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was 11.925% for the 182-day and 13.250% for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

The Central Bank reserves the right to accept/reject bids in part or in full without giving any reason. Individual bids must be of a minimum face value of Kshs.100,000.00. Only investors with active CDS accounts are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 2nd March, 2016 for 182 & 364-day and Thursday, 3rd March, 2016 for 91-day Treasury Bills. Payments above Kshs.1 Million must be made by electronic tranfer using RTGS. Payments below Kshs. 1 Million may be made by Cash, Banker's Cheque or RTGS and must reach the Central Bank not later than Monday, 7th March, 2016, at 2.00 p.m. for Cash and Cheques and 3.00 p.m for RTGS funds transfers. Please provide the following details with each payment: Name, Reference No., Issue No., and include the Portfolio number and the virtual account number.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs.20 Million per investor per tenor and are issued at the weighted average of accepted bids.
