## A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2150/182 & 2077/364 DATED

18/07/2016

This week the Central Bank of Kenya offered 182 and 364 Days Treasury Bills for a total of Kshs.12 Billion. The total number of bids received was 139 amounting to Kshs.3.01 Billion representing 50.16% subscription and 88 bids amounting to Kshs.6.90 Billion representing 115.05% subscription for 182 and 364 days, respectively. Bids accepted amounted to Kshs.2.71 Billion for 182 days and Kshs. 6.64 Billion for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was 9.914% for the 182-day and 10.869% for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

Only investors with active CDS accounts are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday, 20th July, 2016 for 182 & 364 days and Thursday, 21st July, 2016 for 91-day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs.1 Million may be made by Cash, Banker's Cheque or RTGS. These payments must reach the Central Bank not later than Monday, 25th July 2016, 2.00 p.m. for Cash and Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS Portfolio No. and the customer's Virtual account No.

## D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs.20 Million per investor per tenor and are issued at the weighted average of accepted bids.
