## A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2154/182 & 2081/364 DATED

15/08/2016

This week the Central Bank of Kenya offered 182 and 364 Days Treasury Bills for a total of Kshs.12 Billion. The total number of bids received was 185 amounting to Kshs.10.75 Billion representing 179.25% subscription and 119 bids amounting to Kshs. 4.59 Billion representing 76.51% subscription for 182 and 364 days, respectively. Bids accepted amounted to Kshs.6.007 Billion for 182 days and Kshs. 4.590 Billion for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was 10.811% for the 182-day and 11.684% for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

Where several successful bidders quote a common rate, the Central Bank of Kenya reserves the right to allot bids on a pro-rata basis. The Central Bank reserves the right to accept/reject bids in part or in full without giving any reason. Individual bids must be of a minimum face value of Kshs.100,000.00. Only investors with active CDS accounts are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday,17th August,2016 for 182 & 364 days and Thursday,18th August, 2016 for 91-day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs.1 Million may be made by Cash, Banker's Cheque or RTGS. These payments must reach the Central Bank not later than Monday, 22nd August 2016, 2.00 p.m. for Cash and Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS Portfolio No. and the customer's Virtual account No.

## D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs.20 Million per investor per tenor and are issued at the weighted average of accepted bids.
