The total number of bids received was 156 amounting to Kshs 1.38 Billion, representing a subscription of 46%. Total bids accepted amounted to Kshs. 987 Million. The market weighted average rate was 9.506%, and the weighted average of accepted bids which will be applied for non-competitive bids was 9.405% down from 9.432% in the previous auction.
