A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2033/182 & 1953/364 DATED

21/04/2014

This week the Central Bank of Kenya offered 182 and 364 Days Treasury Bills for a total of Kshs 6 Billion. The total number of bids received was 97 amounting to Kshs. 6.10 Billion representing 203.50% subscription and 120 bids amounting to Kshs. 8.40 Billion representing 279.94% subscription for 182 and 364 days, respectively. Bids accepted amounted to Kshs. 4.92 Billion for 182 days and Kshs. 6.63 Billion for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was 9.812% for the 182-day and 10.111% for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday,23rd April,2014 for 182-day and 364-day and Thursday, 24th April,2014 for 91- day Treasury Bills. Payments above Kshs. 1 Million must be made by electronic tranfer using RTGS. Payments below Kshs. 1 Million may be made by Cash, Banker's Cheque or RTGS and must reach the Central Bank not later than Monday 28th April,2014, 2.00 p.m. for Cash and Cheques and 3.00 p.m for RTGS funds transfers. Please provide the following details with each payment: Name, Reference No., Issue No., and include the Portfolio number and the Investor's virtual account number.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor per tenor and are issued at the weighted average of accepted bids.
