The total number of bids received was 169 amounting to Kshs 1.68 Billion, representing a subscription of 55.96%. Total bids accepted amounted to Kshs.1.63 Billion. The market weighted average rate was 9.192%, and the weighted average of accepted bids which will be applied for non-competitive bids was 9.187% up from 9.174% in the previous auction.
