## A. RESULTS OF FXD3/2008/10 AND FXD1/2009/10 TREASURY BONDS DATED 24/04/2017

This month the Central Bank of Kenya offered two 10-year Treasury Bonds FXD3-2008-10 and FXD1-2009-10 for a total amount of Kshs 30 Billion. The total number of bids received was 281 amounting to Kshs 21.76 Billion and 300 amounting to Kshs 27.63 Billion for the FXD3/2008/10 and FXD1/2009/10 bond respectively. The weighted average rate for successful bids was 11.330% for the FXD3/2008/10 Bond and 11.974% for the FXD1/2009/10 Bond. The other auction statistics are summarised in the table below.
