

**A. RESULTS OF 182 DAYS TREASURY BILLS ISSUE NO. 1935 VALUE DATED 04/06/2012**

This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 2 Billion. The total number of bids received was 93 amounting to Kshs 1.2 Billion, representing a subscription of 59%. Bids accepted amounted to Ksh. 1.2 Billion. The market weighted average rate was 10.327% while the weighted average rate of accepted bids, which will be applied for non-competitive bids was 10.327% down from 10.915% recorded in the previous auction. The other auction statistics are summarised in the table below.

Where several successful bidders quote a common rate, the Central Bank of Kenya reserves the right to allot bids on a pro-rata basis. The Central Bank reserves the right to accept/reject bids in part or in full without giving any reason. Individual bids must be of a minimum face value of Kshs 100,000.00. Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 6th June 2012 for 182 & 364 and Thursday 7th June 2012 for 91 days Treasury Bills respectively. Payments above Kshs. 1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Monday 11th June 2012 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., the New CDS Portfolio and the customer's Virtual account No.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
