A. RESULTS OF 91 DAYS TREASURY BILLS ISSUE NO. 1931 VALUE DATED

26/12/2011

This week the Central Bank of Kenya offered 91 day Treasury Bills for a total of **Kshs 4 Billion**. The total number of bids received was 386 amounting to **Kshs. 2.86 Billion**, representing a subscription of 72%. Bids accepted amounted to **Kshs 2.1 Billion**. The market weighted average rate was **19.309%**, while the weighted average rate of accepted bids, which will be applied for non-competitive bids, was **18.948%** up from **18.659%** in the previous auction. The other auction statistics are summarised in the table below.

Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 28th December 2011 for 182 Day and Thursday 29th December 2011 for 91 Day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Tuesday 3rd January 2012 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS account No., and include 'Government Treasury Bills Suspense A/c no. 01-070-0001' when using RTGS.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
