A. RESULTS OF 91 DAYS TREASURY BILLS ISSUE NO. 1912 VALUE DATED

15/08/2011

This week the Central Bank of Kenya offered 91 day Treasury Bills for a total of **Kshs 2 Billion**. The total number of bids received was 108 amounting to **Kshs. 1.62 Billion**, representing a subscription of 81%. Bids accepted amounted to **Kshs 1.62 Billion**. The market weighted average rate of accepted bids, which will be applied for non-competitive bids was **9.145% up from 9.015%** in the previous auction. The other auction statistics are summarised in the table below.

Payments above Kshs. 1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Monday 22nd August 2011 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS account No., and include 'Government Treasury Bills Suspense A/c no. 01-070-0001' when using RTGS.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
