



A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2019/182 & 1938/364 DATED

13/01/2014

This week the Central Bank of Kenya offered 182 and 364 Days Treasury Bills for a total of Kshs 6 Billion. The total number of bids received was 58 amounting to Kshs. 2.56 Billion representing 85% subscription and 40 bids amounting to Kshs. 1.90 Billion representing 63% subscription for 182 and 364 days respectively. Bids accepted amounted to Kshs. 2.51 Billion for 182 days and Kshs. 940 Million for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was 10.359% for the 182 Day and 10.650% for 364 days Treasury Bills. The other auction statistics are summarised in the table below.

The Central Bank reserves the right to accept/reject bids in part or in full without giving any reason. Individual bids must be of a minimum face value of Kshs 100,000.00. Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on **Wednesday, 15th January 2014** for 182-day and 364-day and **Thursday, 16th January 2014** for 91- day Treasury Bills. Payments above Kshs. 1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Cash, Banker's Cheque or RTGS and must reach the Central Bank not later than **Monday, 20th January 2014, 2.00 p.m.** for Cash and Cheques and 3.00 p.m for RTGS funds transfers. Please provide the following details with each payment: Name, Reference No., Issue No., and include the Portfolio number and the Investor's virtual account number.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of **Kshs. 20 Million** per investor per tenor and are issued at the weighted average of accepted bids.
