In response to the enquiries the Bank has issued addendum No. 1 is respect to the tender by modifying the tender document as follows:

SECTION D: APPENDIX TO INSTRUCTION TO THE TENDERERS: Special notes to all tenderers – page 17:

No. 8 should read as follows: The tenders shall remain valid for **120 days** from the date of tender opening.

SECTION F: DESCRIPTION OF SERVICES - Page 22

The number of Air Conditioning Equipment to be serviced is 52 and not 38

SECTION G: DESCRIPTION OF AIR CONDITIONERS - Pages 24/25

Item No. 16 and 17: Capacity is **24,000 BTU/HR** and **NOT** "2424,000 BTU/HR"

SECTION H: TENDER QUALIFICATION AND AWARD - PAGE 27

This section is modified by reorganizing the section as follows:

The received tenders will be evaluated in three stages as detailed below:

- 1. Stage 1: Compliance with Mandatory Requirements;
- 2. Stage 2: The Technical Evaluation (Capacity to Deliver the Service)
- 3. Stage 2: The Financial Evaluation (Quoted prices)

Stage1: Compliance with Mandatory Requirements (MR)

Bidders meeting all the Mandatory Requirements will qualify to proceed to stage 2 of the evaluation on technical evaluation on capacity to deliver the service.

Bidders that score 75% and above on the Technical Evaluation on capacity to deliver the service will qualify for Financial Evaluation. Financial Evaluation shall comprise of checking the completeness and accuracy of the tender including correctness of the figures entered in the price schedule. After correction of errors bids will then be ranked from lowest to the highest and the Lowest Evaluated Bid will be recommended for the award of the contract.
