# DATA SPECIFICATION TEMPLATE VALIDATION RULES



Version 4 of the Data Specification Template Validation has been released by the Central Bank of Kenya, following consultations among commercial banks, the Kenya Deposit Insurance Corporation (KDIC), Microfinance Banks and the Credit Reference Bureaus; for the implementation of full-file credit information sharing. Its purpose is to standardise the validation rules as per the DST requirement. These consultations have been coordinated by the Credit Information Sharing Association of Kenya (CIS Kenya).

CIS Kenya is a member association of credit providers and credit bureaus mandated with the development and implementation of the credit information sharing mechanism in Kenya.

## 1. Introduction

This document has been developed to give clear guidelines on what to check whenever credit reference bureaus are to validate data submitted by the credit providers.

### 1.1. General Conventions

Each file in this DST Validation rules has 5 distinct columns namely;

#### 1.1.1. Field

The header of a field that denotes the what information is expected in that field

#### 1.1.2. Business Rules

This column contains an explanation of the data expected in a specific field. Some fields contain lists, for example, the Marital Status field. If the borrower is married, then the data expected in the field is “M”, and NOT the word “Married”.

#### 1.1.3. Checks

This column lists various parameters that the CRBs would be checking on a specific field.

### 1.2. General Guidelines for this document

The following are some of the guiding principles on the action points to this document;

- i. Mandatory Field
  - a. The field **MUST** be provided. If its blank it **MUST** be Rejected
  - b. The field **MUST** follow the right format. If invalid format it **MUST** be Rejected

***Whatever outcome of these actions would affect the acceptance rate***

- ii. Mandatory, issue warning Field
  - a. If Field is not provided. Accept the record but issue warning. This will not affect the acceptance rate
  - b. If the Field is provided but the format is invalid. Reject the record. This will affect the acceptance rate
- iii. Optional field (The field that is not mandatory or mandatory, issue warning)
  - a. If field format is invalid. Accept but issue warning

**Note: Snapshot Date** refers to the specific date of submission
