

**A. RESULTS OF 182 DAYS TREASURY BILLS ISSUE NO. 1962 VALUE DATED 10/12/2012**

This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 3 Billion. The total number of bids received was 74 amounting to Kshs 1.46 Billion, representing a subscription of 49%. Bids accepted amounted to Ksh.1.46 Billion. The market weighted average rate was 9.08% while the weighted average rate of accepted bids, which will be applied for non-competitive bids was 9.08% down from 9.336% recorded in the previous auction. The other auction statistics are summarised in the table below.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Thursday 13th December 2012 for 182 and 91 days Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Monday 17th December 2012 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., the New CDS Portfolio and the customer's Virtual account No.
