A. RESULTS OF 182 DAYS TREASURY BILLS ISSUE NO. 1972 VALUE DATED 18/02/2013

This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 4 Billion. The total number of bids received was 53 amounting to Kshs 1.32 Billion, representing a subscription of 33%. Bids accepted amounted to Ksh.1.21 Billion. The market weighted average rate was 8.646% while the weighted average rate of accepted bids, which will be applied for non-competitive bids was 8.502% up from 8.450% recorded in the previous auction. The other auction statistics are summarised in the table below.

Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 20th February 2013 and Thursday 21st February 2013 for 182 and 91 days Treasury Bills respectively. Payments above Kshs. 1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Monday 25th February 2013 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., the New CDS Portfolio and the customer's Virtual account No.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.

E. COMPETITIVE BIDS

Competitive Bidders must quote their desired Interest Rate(%) and not Price per Kes 100. New application forms are available on the CBK website.
