**A. RESULTS OF 91 DAYS TREASURY BILLS ISSUE NO. 2012 VALUE DATED 15/07/2013**

This week the Central Bank of Kenya offered 91-day Treasury Bills for a total of **Kshs.2 Billion**. The total number of bids received was **153** amounting to **Kshs 1.41 Billion**, representing a subscription of **71%**. Total bids accepted amounted to **Kshs.1.41 Billion**. The market weighted average rate was **5.759%**, and the weighted average of accepted bids which will be applied for non-competitive bids was **5.759%** up from **5.496%** in the previous auction. The other auction statistics are summarised in the table below.

Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 17th July 2013 for 182-day and 364-day and Thursday 18th July 2013 for 91 day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS. These payments must reach the Central Bank not later than Monday 22nd July 2013 2.00 p.m. for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., the New CDS Portfolio and the customer's Virtual account No.

**D. NON-COMPETITIVE BIDS**

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
