**A. RESULTS OF 91 DAYS TREASURY BILLS ISSUE NO. 2013 VALUE DATED 22-07-2013**

This week the Central Bank of Kenya offered 91-day Treasury Bills for a total of **Kshs.3 Billion**. The total number of bids received was **137** amounting to **Kshs 1.306 Billion**, representing a subscription of **44%**. Total bids accepted amounted to **Kshs.1.305 Billion**. The market weighted average rate was **6.297%**, and the weighted average of accepted bids which will be applied for non-competitive bids was **6.293%** up from **5.759%** in the previous auction. The other auction statistics are summarised in the table below.

Where several successful bidders quote a common rate, the Central Bank of Kenya reserves the right to allot bids on a pro-rata basis. The Central Bank reserves the right to accept/reject bids in part or in full without giving any reason. Individual bids must be of a minimum face value of Kshs. 100,000.00. Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 24th July 2013 for 182-day and 364-day and Thursday 25th July 2013 for 91 day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS. These payments must reach the Central Bank not later than Monday 29th July 2013 2.00 p.m. for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., the New CDS Portfolio and the customer's Virtual account No.

**D. NON-COMPETITIVE BIDS**

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
