**A. RESULTS OF 91 DAYS TREASURY BILLS ISSUE NO. 2155 VALUE DATED**

**11/04/2016**

This week the Central Bank of Kenya offered 91-day Treasury Bills for a total of **Kshs.4 Billion**. The total number of bids received was **222** amounting to **Kshs 5.58 Billion**, representing a subscription of **139.53%**. Total bids accepted amounted to **Kshs 5.20 Billion**. The market weighted average rate was **9.021%**, and the weighted average of accepted bids which will be applied for non-competitive bids was **9.001%** up from **8.965%** in the previous auction. The other auction statistics are summarised in the table below.

Only investors with active CDS accounts are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday, 13th April, 2016 for 182-day and 364-day and Thursday 14th April, 2016 for 91-day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs.1 Million may be made by Cash, Banker's Cheque or RTGS. These payments must reach the Central Bank not later than Monday, 18th April 2016, 2.00 p.m. for Cash and Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS Portfolio No. and the customer's Virtual account No.
