



A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2059/182 & 1981/364 DATED

20/10/2014

This week the Central Bank of Kenya offered 182 and 364 Days Treasury Bills for a total of **Kshs.9 Billion**. The total number of bids received was 56 amounting to **Kshs.3.71 Billion** representing **93%** subscription and 47 bids amounting to **Kshs.11.46 Billion** representing **229%** subscription for 182 and 364 days, respectively. Bids accepted amounted to **Kshs.2.51 Billion** for 182 days and **Kshs.7.72 Billion** for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was **8.986%** for the 182-day and **10.172%** for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

The Central Bank reserves the right to accept/reject bids in part or in full without giving any reason. Individual bids must be of a minimum face value of Kshs. 100,000.00. Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by **2.00 p.m. on Wednesday, 22nd October, 2014** for 182-day & 364-day and **Thursday, 23rd October, 2014** for 91-day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Cash, Banker's Cheque or RTGS and must reach the Central Bank not later than **Monday, 27th October, 2014, 2.00 p.m.** for Cash and Cheques and 3.00 p.m for RTGS funds transfers. Please provide the following details with each payment: Name, Reference No., Issue No., and include the Portfolio number and the Investor's virtual account number.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of **Kshs. 20 Million** per investor per tenor and are issued at the weighted average of accepted bids.
