A. RESULTS OF 91 DAYS TREASURY BILLS ISSUE NO. 2084 VALUE DATED 01/12/2014

This week the Central Bank of Kenya offered 91-day Treasury Bills for a total of **Kshs.3 Billion**. The total number of bids received was **154** amounting to **Kshs. 2.35 Billion**, representing a subscription of **78%**. Total bids accepted amounted to **Kshs. 1.13 Billion**. The market weighted average rate was **8.832 %**, and the weighted average of accepted bids which will be applied for non-competitive bids was **8.605%** up from **8.597%** in the previous auction. The other auction statistics are summarised in the table below.
