A. RESULTS OF 182 DAYS TREASURY BILLS ISSUE NO. 1905 VALUE DATED

07/11/2011

This week the Central Bank of Kenya offered 182 day Treasury Bills for a total of Kshs 3 Billion. The total number of bids received was 103 amounting to Kshs 543 Million, representing a subscription of 18%. Consequently, the weighted average rate of accepted bids, which will be applied for non-competitive rose to 15.742% from 15.364% recorded in the previous auction. The other auction statistics are summarised in the table below.

Only CDS holders with updated mandates are eligible.

Bids must be submitted using the specified format and must reach the Central Bank (HQ, Branch or Currency Centre) by 2.00 p.m. on Wednesday 9th November 2011 for 182 and 364 Day Treasury Bills and Thursday 10th November 2011 for 91 Day treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Banker's Cheque or RTGS and must reach the Central Bank not later than 2.00 p.m. on Monday 14th November 2011 for Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS account No., and include 'Government Treasury Bills Suspense A/c no. 01-070-0001' when using RTGS.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs. 20 Million per investor and are issued at the weighted average of accepted bids.
