Bids must be submitted and received by CBK either **manually** (application forms delivered in Treasury Bill tender boxes in any Branch or Currency Centre of Central Bank of Kenya) or **electronically** (via **Treasury Mobile Direct** or **CBK Internet Banking** - commercial banks) by **2.00 p.m.** on **Thursday, 12th March, 2020** for 91-day, 182-day and 364-day Treasury Bills. Payments above Kshs. 1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Cash, Banker's Cheque or RTGS. These payments must reach the Central Bank not later than **2.00 p.m** on **Monday, 16th March, 2020**. Please provide the following details with each payment: Name, Reference No., CDS/ Portfolio Account No., Issue No. and the Virtual Account No.

D NON-COMPETITIVE BIDS
