## A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2165/182 & 2092/364 DATED

31/10/2016

This week the Central Bank of Kenya offered 182 and 364 Days Treasury Bills for a total of Kshs.12 Billion. The total number of bids received was 355 amounting to Kshs. 7.357 Billion representing 122.61% subscription and 234 bids amounting to Kshs.5.423 Billion representing 90.38% subscription for 182 and 364 days, respectively. Bids accepted amounted to Kshs.7.357 Billion for 182 days and Kshs.5.423 Billion for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was 10.270% for the 182-day and 10.576% for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

Only investors with active CDS accounts are eligible.

Bids must be submitted and received by CBK either manually (application forms delivered in Treasury Bill tender boxes in any Branch or Currency Centre of Central Bank of Kenya or electronically (via CBK Internet Banking platform for commercial Banks) by 2.00 p.m. on Wednesday, 2nd November, 2016 182 & 364 days and Thursday, 3rd November, 2016 91 day Treasury Bills. Payments above Kshs. 1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Cash, Banker's Cheque or RTGS. These payments must reach the Central Bank not later than Monday, 07th November 2016, 2.00 p.m. for Cash and Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS Portfolio No. and the customer's Virtual account No.

## D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs.20 Million per investor per tenor and are issued at the weighted average of accepted bids.
