### A. RESULTS OF 182-DAY & 364-DAY TREASURY BILLS ISSUES 2167/182 & 2094/364 DATED

14/11/2016

This week the Central Bank of Kenya offered **182** and **364 Days** Treasury Bills for a total of **Kshs.12 Billion**. The total number of bids received was **438** amounting to **Kshs. 9.60 Billion** representing **159.96%** subscription and **189** bids amounting to **Kshs.12.90 Billion** representing **215.02%** subscription for 182 and 364 days, respectively. Bids accepted amounted to **Kshs.6.66 Billion** for 182 days and **Kshs.11.82 Billion** for 364 days Treasury Bills. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was **10.302%** for the 182-day and **10.717%** for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

Only investors with active CDS accounts are eligible.

Bids must be submitted and received by CBK either manually (application forms delivered in Treasury Bill tender boxes in any Branch or Currency Centre of Central Bank of Kenya or electronically (via CBK Internet Banking platform for commercial Banks) by 2.00 p.m. on Wednesday, 16th November, 2016 for 182 & 364 days and Thursday, 17th November, 2016 for 91 day Treasury Bills. Payments above Kshs. 1 Million must be made by electronic transfer using RTGS. Payments below Kshs. 1 Million may be made by Cash, Banker's Cheque or RTGS.These payments must reach the Central Bank not later than Monday, 21st November 2016, 2.00 p.m. for Cash and Cheques and 3.00 p.m for RTGS electronic fund transfers. Please provide the following details with each payment: Name, Reference No., CDS Portfolio No. and the customer's Virtual account No.

## D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs.20 Million per investor per tenor and are issued at the weighted average of accepted bids.
