The total number of bids received was 196 amounting to Kshs 4.93 Billion, representing a subscription of 123.34%. Total bids accepted amounted to Kshs. 4.81 Billion. The market weighted average rate was 8.663% and the weighted average of accepted bids which will be applied for non-competitive bids was 8.661% up from 8.648% in the previous auction.
