

A. RESULTS OF 91, 182 & 364 DAYS TREASURY BILLS ISSUE 2213/91, 2186/182 & 2124/364 DATED

22/05/2017

This week the Central Bank of Kenya offered **91**, **182** and **364 Days** Treasury Bills for a total of **Kshs**. **24 Billion**. The total amount received was **Kshs**. **41.41 Billion** and the bids accepted amounted to **Kshs.32.50 Billion**. The weighted average rate of accepted bids, which will be applied for non-competitive bids, was **8.677%** for the 91-day, **10.389** for 182-day and **10.914%** for 364-day Treasury Bills. The other auction statistics are summarised in the table below.

The Central Bank reserves the right to accept/reject bids in part or in full without giving any reason. Individual bids must be of a minimum face value of Kshs.100,000.00. Only investors with active CDS accounts are eligible.

Bids must be submitted and received by CBK either **manually** (application forms delivered in Treasury Bill tender boxes in any Branch or Currency Centre of Central Bank of Kenya or **electronically** (via CBK Internet Banking platform for commercial Banks) by 2.00 p.m. on **Thursday, 25th May 2017** for 91-day, 182-day and 364-day Treasury Bills. Payments above Kshs.1 Million must be made by electronic transfer using RTGS. Payments below Kshs.1 Million may be made by Cash, Banker's Cheque or RTGS.These payments must reach the Central Bank not later than Monday, **29th May,2017**, 2.00 p.m. Please provide the following details with each payment: Name, Reference No., CDS Portfolio No.,Issue No. and the customer's Virtual account No.

D. NON-COMPETITIVE BIDS

Non-competitive bids are subject to a maximum of Kshs.20 Million per investor per tenor and are issued at the weighted average of accepted bids.
