The total number of bids received was 164 amounting to Kshs.3.47 Billion, representing a subscription of 86.79%. Total bids accepted amounted to Kshs. 3.45 Billion. The market weighted average rate was 8.555% and the weighted average of accepted bids which will be applied for non-competitive bids was 8.552% down from 8.553% in the previous auction.
