PRESS STATEMENT

The Central Bank of Kenya (CBK) notes with concern the erroneous article and reckless banner headline "CBK pays its chair sh6m retainer in year of no meeting" in the "Business Daily" of December 8, 2016. The article levels several misguided charges against the CBK, the CBK Board Chairman, and the CBK Governor. These accusations include: that the Chairman was paid Ksh.6 million in FY15/16 as a retainer (which was flagged as equivalent to Ksh.500,000 a month), and CBK's purported failure to exercise prudence in the management of its resources. These allegations are repeated by Business Daily of December 9, 2016, page 2 and Editorial, page 14.

CBK wishes to clarify the following:

- 1. The financial accounts for FY15/16 were audited and published as required by law, and the auditor's opinion was unqualified.
- 2. Explanatory Note 28(ii) to the audited accounts discloses the item "Fees to non-executive directors" of Ksh.6 million. These payments were made in line with policy guidelines issued in 2014.
- 3. The reporting of Explanatory Note 28(ii) is in keeping with the requirements of International Accounts Standards IAS24 and the figure is broken down as follows:
