## KEY MONETARY AND FINANCIAL INDICATORS

# **Exchange Rate**

The Kenya Shilling strengthened against major international and regional currencies during the week ending May 7. It exchanged at KSh 106.08 per US dollar on May 7 compared to KSh 107.29 per US dollar on April 30 (Table 1).

## **Foreign Exchange Reserves**

The CBK usable foreign exchange reserves remained adequate at USD 7,809 million (4.70 months of import cover) as at May 7. This meets the CBK's statutory requirement to endeavor to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (Table 2).

#### **Money Market**

The money market was liquid during the week ending May 7, supported by government payments, which offset tax receipts. Commercial banks' excess reserves stood at KSh 39.9 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 4.05 percent on May 7 compared to 4.27 percent on April 30. The average number of interbank deals per day decreased to 20 from 23 in the previous week, while the value traded decreased to KSh 7.9 billion from KSh 12.3 billion in the previous week (Table 3).

## **Government Securities Market**

The Treasury bills auction of May 7 received bids totaling KSh 15.0 billion against an advertised amount of KSh 24.0 billion, representing a performance of 62.6 percent. Interest rates on all the Treasury bill tenors increased marginally (Table 4).

The 5-year Treasury bond offered at the auction of May 6 received bids totaling KSh 34.5 billion against an advertised amount of KSh 50.0 billion, representing a performance of 69.1 percent (Table 5). The interest rate for the bond increased slightly compared to the previous issue of similar Treasury bond.

# **Equity Market**

At the Nairobi Securities Exchange, the NASI, NSE 25 and NSE 20 share price indices rose by 2.2 percent, 3.2 percent and 4.3 percent, respectively, during the week ending May 7. Similarly, market capitalization, number of shares traded and equity turnover rose by 2.2 percent, 0.79 percent and 60.1 percent, respectively (Table 6).

#### **Bond Market**

Turnover of bonds traded in the domestic secondary market increased by 19.2 percent during the week (Table 6). In the international market, yields on Kenya's Eurobonds declined by an average of 60.5 basis points. The yields on the 10- year Eurobonds for Angola and Ghana also declined (Chart 2).

### **Global Trends**

Global financial markets remained cautiously optimistic during the week following the gradual easing of lockdown restrictions in parts of Europe and some US States. However, vulnerabilities persisted as the US employment report released on May 8, revealed unprecedented job losses arising from Covid-19 pandemic .

International oil prices recovered in the week, supported by the gradual easing of the lockdowns in some countries which is expected to boost demand. Murban oil price increased to USD 27.67 per barrel on May 6 from USD 21.97 per barrel on April 30.

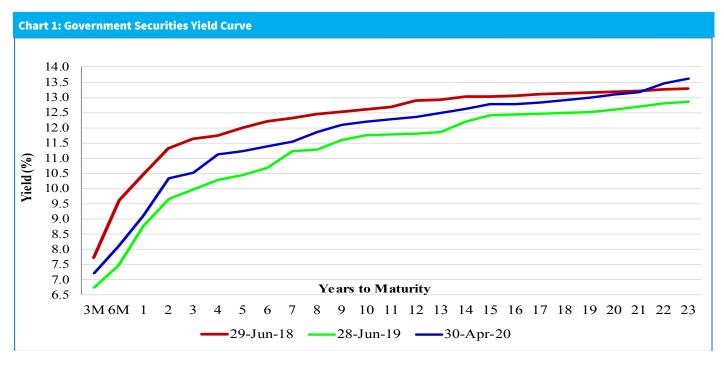

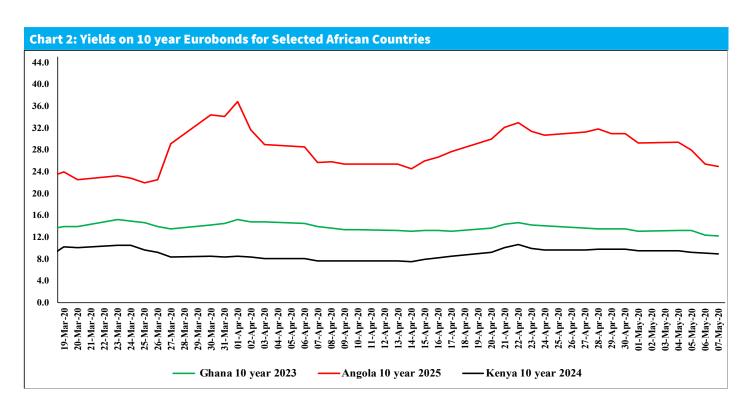
