## **KEY MONETARY AND FINANCIAL INDICATORS**

## **Exchange Rates**

The Kenya Shilling remained relatively stable against major international and regional currencies during the week ending September 24. It exchanged at KSh 108.41 per US dollar on September 24 compared to KSh 108.38 per US dollar on September 17 (Table 1).

# **Foreign Exchange Reserves**

The CBK usable foreign exchange reserves remained adequate at USD 8,627 million (5.23 months of import cover) as at September 24. This meets the CBK's statutory requirement to endeavour to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (Table 2).

#### **Remittances**

Remittance inflows remained strong in August 2020 amounting to USD 274.1 million compared to USD 214.3 million in August 2019, and USD 277.0 million in July 2020 (Chart 1) in line with seasonal factors. The cumulative inflows in the 12 months to August 2020 totalled USD 2,921 million compared to USD 2,776 million in the 12 months to August 2019, an increase of 5.2 percent. Inflows from the US, United Kingdom, Saudi Arabia and Qatar increased, while those from South Africa and Germany declined marginally compared to July 2020.

#### **Current Account**

Preliminary data on balance of payments shows that the current account deficit remained stable at 4.7 percent of GDP in the 12 months to August 2020, similar to the level in July. This reflected lower oil imports and improvement in exports of tea, horticulture as well as remittances (Chart 2).

#### **Money Markets**

Liquidity in the money market was relatively tight during the week ending September 24, mainly as a result of tax remittances which more than offset government payments. Commercial banks' excess reserves stood at KSh 14.1 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 3.34

percent on September 24 compared to 2.87 percent on September 17. The average number of interbank deals per day remained stable at 24 while the value traded increased to KSh 13.3 billion from KSh 11.3 billion in the previous week (Table 3).

#### **Government Securities Market**

The Treasury bills auction of September 24 received bids totalling KSh 7.1 billion against an advertised amount of KSh 24.0 billion, representing a performance of 29.7 percent. Interest rates on the Treasury bills increased marginally (Table 4).

# **Equity Market**

At the Nairobi Securities Exchange, all the share price indices remained relatively stable during the week ending September 24. The NSE 25 share price index rose by 0.1 percent, while both NASI and NSE 20 share price index declined marginally by 0.1 percent and 0.7 percent, respectively. Market capitalisation declined marginally (Table 6).

## **Bond Market**

Turnover of bonds traded in the domestic secondary market decreased by 34.4 percent during the week ending September 24 (Table 6). In the international market, yields on Kenya's Eurobonds increased by an average of 74.9 basis points. The yields on the 10-year Eurobonds for Angola and Ghana also increased (Chart 4).

#### **Global Trends**

Global financial markets were cagey during the week ending September 24, largely due to uncertainties surrounding the global economic outlook following renewed COVID-19 infections in Europe and reimposition of restrictions in selected countries.


International oil prices declined marginally during the week due to weak global demand. Murban oil price declined to USD 41.49 per barrel on September 24 from USD 42.01 per barrel on September 17.






