



# RECENT MONETARY AND FINANCIAL DEVELOPMENTS

# **Exchange Rates**

The Kenya Shilling remained stable against major international and regional currencies during the week ending March10. It exchanged at KSh 114.14 per US dollar on March 10, compared to KSh 113.89 per US dollar on March 3 (Table 1).

# **Foreign Exchange Reserves**

The usable foreign exchange reserves remained adequate at USD 8,011 million (4.90 months of import cover) as at March 10. This meets the CBK's statutory requirement to endeavour to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (**Table 2**).

#### **Current Account**

Provisional data on balance of payments shows that the current account deficit was estimated at 5.6 percent of GDP in the 12 months to January 2022, compared to 4.3 percent of GDP in the 12 months to January 2021 **(Chart 1)**. The wider deficit reflects a higher import bill, particularly oil, which more than offset increased receipts from agricultural and services exports, and remittances.

## **Money Market**

The money market was liquid during the week ending March 10, partly reflecting government payments, which offset tax remittances. Commercial banks' excess reserves stood at KSh 16.9 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 4.68 percent on March 10 compared to 5.36 percent on March 3. During the week, the average number of interbank deals increased to 22 from 20 in the previous week, while the average value traded increased to KSh 12.9 billion compared with KSh 10.2 billion in the previous week (**Table 3**).

#### **Goverment Securities Market**

The Treasury bill auction of March 10 received bids totalling KSh 24.5 billion against an advertised amount of KSh

24.0 billion, representing a performance of 102.1 percent. Interest rates on all tenors declined marginally (Table 4).

During the Treasury bond auction of March 9, the reopened five, fifteen and twenty five-year fixed rate Treasury bonds issued received bids totalling KSh 40.9 billion against an advertised amount of KSh 50.0 billion, representing a performance rate of 81.9 percent (**Table 5**).

## **Equity Market**

At the Nairobi Securities Exchange, NASI, NSE 25 and NSE 20 share price indices declined by 4.0 percent, 2.3 percent and 1.3 percent, respectively. Market capitalization and total shares traded declined by 4.0 percent and 6.8 percent, respectively, while equity turnover increased by 12.8 percent during the week ending March 10 (**Table 6**).

## **Bonds Market**

Bonds turnover in the domestic secondary market declined by 0.6 percent during the week ending March 10 **(Table 6).** In the international market, yields on Kenya's Eurobonds rose by an average of 63.2 basis points. The yields on the 10-year Eurobond for Ghana increased, while that for Angola declined **(Chart 3).** 

#### **Global Trends**


The ongoing Russia-Ukraine conflict and discussions aimed at addressing the conflict dominated the week ending March 10. Inflation in the advanced economies remains a major concern, with the US inflation rising to 7.9 percent in February 2022.

International oil prices remained volatile during the week ending March 10, reflecting demand-supply mismatch caused by the ongoing Russia-Ukraine conflict. Murban oil price declined to USD 117.24 per barrel on March 10 from USD 119.23 per barrel on March 3.




