



RECENT MONETARY AND FINANCIAL DEVELOPMENTS

Exchange Rates

The Kenya Shilling remained stable against major international and regional currencies during the week ending October 7. It exchanged at KSh 110.69 per US dollar on October 7, compared to KSh 110.49 per US dollar on September 30 (**Table 1**).

Foreign Exchange Reserves

The usable foreign exchange reserves remained adequate at USD 9,365 million (5.73 months of import cover) as at October 7. This meets the CBK's statutory requirement to endeavor to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (**Table 2**).

Money Market

The money market was liquid during the week ending October 7, partly reflecting government payments. Commercial banks' excess reserves stood at KSh 11.8 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 6.11 percent on October 7 compared to 6.61 percent on September 30. During the week, the average number of interbank deals per day increased to 29 from 25 in the previous week, while the average value traded increased to KSh 11.7 billion from KSh 10.1 billion in the previous week (Table 3).

Government Securities Market

The Treasury bill auction of October 7 received bids totaling KSh 9.8 billion against an advertised amount of KSh 24.0 billion, representing a performance of 40.9 percent. Interest rates on the 91-day, 182-day and 364-day, Treasury bills remained stable (**Table 4**).

During the Treasury Bond Auction of October 6, the two re-opened fifteen year and twenty five year treasury bonds issued received bids totalling KSh 55.5 billion against an advertised amount of KSh 60.0 billion, representing a performance rate of 92.5 percent (**Table 5**).

Equity Market

At the Nairobi Securities Exchange, the equity turnover increased by 7.9 percent. However, the NASI, NSE 25 and NSE 20 share price indices declined by 0.3 percent, 1.2 percent and 6.1 percent, respectively. Similarly, total shares traded and market capitalization, declined by 6.7 percent and 0.4 percent, respectively during the week ending October 7 (Table 6).

Bonds Market

Bonds turnover in the domestic secondary market declined by 49.9 percent during the week ending October 7 **(Table 6).** In the international market, yields on Kenya's Eurobonds increased by an average of 27.8 basis points. Yields on the 10-year Eurobonds for Angola and Ghana also increased **(Chart 2)**.

Global Trends

Global financial markets sentiment improved during the week ending October 7, as investors' concern on the US debt ceiling and increasing crude oil prices eased. Market sentiment was also driven by expectations of release of the US job report.

International oil price increased during the week ending October 7. Murban oil price increased to 81.33 on October 6, as OPEC+ confirmed it would stick to its current output policy despite rebounding demand. However, the price declined to 78.30 on October 7 after US indicated that it would tap crude oil from its emergency reserve.

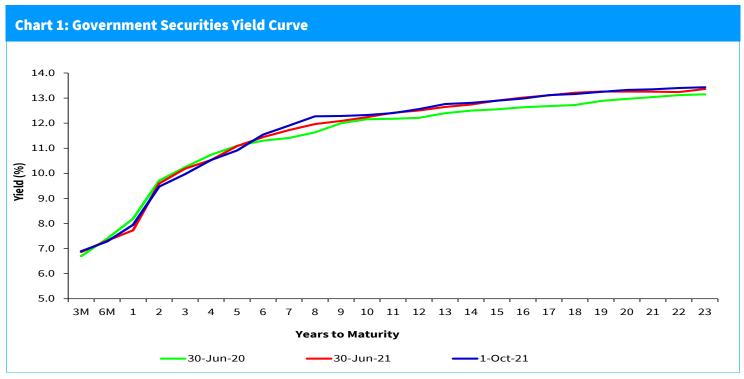

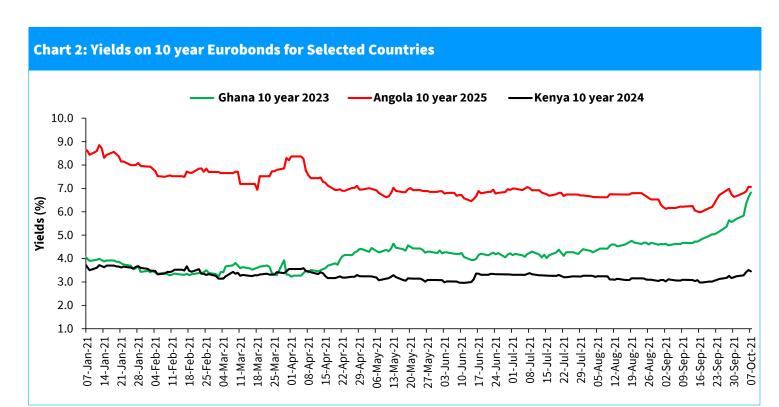
