RECENT MONETARY AND FINANCIAL DEVELOPMENTS

Inflation

Overall inflation declined in April 2024 to the midpoint of the medium-term target range for the first time since February 2022. It declined to 5.0 percent from 5.7 percent in March, mainly driven by a significant decline in fuel and food prices. Food inflation declined to 5.6 percent from 5.8 percent in March, supported by easing prices of selected non-vegetable items following continued favourable weather conditions. Fuel inflation eased to 8.3 percent from 12.3 percent in March 2024 on account of lower electricity costs and pump prices. Meanwhile, Non-foodnon-fuel (NFNF) inflation remained stable reflecting muted demand pressures and continued impact of monetary policy action. It remained unchanged at 3.6 percent in March and April 2024 (Chart 1).

Exchange Rates

The Kenya Shilling remained stable against major international and regional currencies during the week ending May 2. It exchanged at KSh 133.20 per US dollar on May 2, compared to KSh 133.16 per US dollar on April 25 (Table 1).

Foreign Exchange Reserves

The usable foreign exchange reserves remained adequate at USD 7,179 million (3.8 months of import cover) as of May 2. This meets the CBK's statutory requirement to endeavor to maintain at least 4 months of import cover (Table 2).

Money Market

Liquidity in the money market remained adequate during the week ending May 2, supported by open market operations. Commercial banks' excess reserves stood at KSh 15.9 billion in relation to the 4.25 percent cash reserves requirement (CRR). The average interbank rate was 13.83 percent on May 2 compared to 13.90 percent on April 25. During the week, the average number of interbank deals decreased to 38 from 40 in the previous week, while the average value traded was stable at KSh 23.3 billion compared to KSh 23.2 billion in the previous week (Table 3).

Government Securities Market

The Treasury bill auction of May 2 received bids totaling KSh 26.0 billion against an advertised amount of KSh 24.0 billion, representing a performance of 108.2 percent. Interest rate on the 91-day, 182-day, and 364-day Treasury bills remained relatively stable (Table 4).

During the Treasury bond auction of May 2, the reopened 10-year fixed rate Treasury bond received bids totaling KSh 15.0 billion against an advertised amount of KSh 25.0 billion, representing a performance rate of 59.9 percent (Table 5).

Equity Market

At the Nairobi Securities Exchange, the NASI, NSE 25 and NSE 20 share price indices declined by 2.2 percent, 2.1 percent and 1.3 percent during the week ending May 2. Market capitalization, equity turnover and total shares traded also declined by 2.2 percent, 29.7 percent and 28.8 percent, respectively (Table 6).


Bond Market

Bond turnover in the domestic secondary market declined by 10.2 percent during the week ending May 2 (Table 6). In the international market, yields on Kenya's Eurobonds increased by an average of 2.7 basis points. The yield on the 10-Year Eurobonds for Angola declined while that of Zambia increased (Chart 3).

Global Trends

Concerns about inflation in advanced economies remained in the week ending May 2. The U.S. Federal Reserve left interest rates unchanged at the 5.25-5.5 percent range after economic reports indicated that inflation was easing slower than expected. The US dollar index weakened by 0.3 percent against a basket of major currencies during the week ending May 2.

International oil prices declined during the week ending May 2, supported by a renewed diplomatic push in the Middle East to secure a cease-fire in Gaza. Murban oil prices dropped to USD 84.64 per barrel on May 2 compared to USD 88.74 per barrel on April 25.




