



Exchange Rate

The Kenya Shilling remained relatively stable against major international and regional currencies during the week ending April 16. It exchanged at 105.91 per US dollar on April 16 compared to 106.00 on April 9 (Table 1).

Foreign Exchange Reserves

The CBK usable foreign exchange reserves remained adequate at USD 7,913 million (4.78 months of import cover) as at April 16. This meets the CBK's statutory requirement to endeavour to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (Table 2).

Money Market

The money market was liquid during the week ending April 16, supported by government payments, which partly offset receipts from tax and auction of government securities. Commercial banks' excess reserves stood at KSh 50.3 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 5.93 percent on April 16 compared to 5.32 percent on April 9. The average number of interbank deals per day increased to 18 from 14 in the previous week, while the value traded decreased to KSh 5.6 billion from KSh 8.2 billion in the previous week (Table 3).

Government Securities Market

The Treasury bills auction of April 16 received bids totaling KSh 14.3 billion against an advertised amount of KSh 24.0 billion, representing a performance of 59.5 percent. Interest rates on the 91-day and 182-day Treasury bills decreased, while that on the 364-day Treasury bill increased marginally (Table 4).

Equity Market

At the Nairobi Securities Exchange, the NASI and NSE 20 share index increased by 2.7 percent and 0.1 percent, respectively, while market capitalization increased by 2.7 percent during the week ending April 16. However, equity turnover and number of shares traded declined by 55.6 percent and 57.6 percent, respectively, following the short trading week.

Bond Market

The bonds turnover in the domestic secondary market declined by 37.3 percent during the week ending April 16. In the international market, yields on Kenya's Eurobonds increased by an average of 57.5 basis points. The yields on the 10-year Eurobonds for Angola increased, while for Ghana declined (Chart 2).

Global Trends

The impact of the global turmoil arising from coronavirus pandemic was estimated in the IMF's World Economic Outlook released on April 14. The IMF projects global growth to decline to negative 3 percent in 2020, a downgrade of 6.3 percentage points from the January projection. The downward revision cuts across all countries and regions, with Sub-Saharan Africa's growth projected to decline to negative 1.6 percent in 2020.

International oil prices declined further during the week due to weak global demand and unilateral decision by Saudi Arabia to reopen price war by giving price discounts in the Asian markets. Murban oil price declined to USD 20.70 per barrel on April 16 from USD 24.09 per barrel on April 9.




