



RECENT MONETARY AND FINANCIAL DEVELOPMENTS

Exchange rates

The Kenya Shilling remained stable against major international and regional currencies during the week ending October 6. It exchanged at KSh 120.82 per US dollar on October 6, compared to KSh 120.70 per US dollar on September 29 **(Table 1)**.

Foreign Exchange Reserves

The usable foreign exchange reserves remained adequate at USD 7,321 million (4.13 months of import cover) as at October 6. This meets the CBK's statutory requirement to endeavor to maintain at least 4 months of import cover (Table 2).

Money Market

Liquidity in the money market increased during the week ending October 6, partly reflecting government payments which offset tax remittances. Commercial banks' excess reserves stood at KSh 26.2 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 5.11 percent on October 6 compared to 5.50 percent on September 29. During the week, the average number of interbank deals increased slightly to 25 from 24 in the previous week, while the average value traded increased to KSh 14.4 billion from KSh 10.9 billion in the previous week **(Table 3)**.

Government Securities Market

The Treasury bill auction of October 6, received bids totalling KSh 26.4 billion against an advertised amount of KSh 24.0 billion, representing a performance of 110.0 percent. Interest rates remained stable, with 91-day and 182-day Treasury bill rates increasing marginally while the 364-day Treasury bill rate remained unchanged **(Table 4)**.

During the Treasury bond auction of October 5, the reopened ten-year and fifteen-year fixed rate Treasury bonds received bids totalling KSh 18.8 billion against an advertised amount of KSh 40.0 billion, representing a performance rate of 47.0 percent **(Table 5)**.

Equity Market

At the Nairobi Securities Exchange, NASI, NSE 25 and NSE 20 share price indices declined by 4.2 percent, 3.7 percent, and 2.3 percent, respectively. Market capitalization and total equity turnover declined by 4.2 percent and 2.2 percent while total shares traded rose by 12.9 percent, respectively during the week ending October 6 (Table 6).

Bonds Market

Bond turnover in the domestic secondary market declined by 8.0 percent during the week ending October 6 **(Table 6)**. In the international market, yields on Kenya's Eurobonds declined by an average of 90.3 basis points with 2024 maturity declining by 112.4 basis points. The yield on the 10-Year Eurobond for Angola also declined while that for Ghana rose **(Chart 2)**.

Global Trends

Concerns about inflation persisted during the week ending October 6. Emerging markets and developing economies tightened monetary policy further to rein in inflation. The global manufacturing sector PMI weakened from 50.3 in August to 49.8 in September, largely attributed to the deterioration of global trade flows and subdued demand. The index of the US dollar against a basket of major currencies strengthened by 0.01 percent during the week.

International oil prices increased during the week ending October 6, after the OPEC+ members agreed to reduce production by 2 million barrels per day from November. Murban oil price increased to USD 95.21 per barrel on October 6 from USD 88.54 per barrel on September 29.



Chart 1: Government Securities Yield


