KEY MONETARY AND FINANCIAL INDICATORS

Exchange Rates

The Kenya Shilling weakened marginally against major international and regional currencies during the week ending August 20. It exchanged at KSh 108.56 per US dollar on August 20, compared to KSh 108.39 per US dollar on August 13 (Table 1).

Foreign Exchange Reserves

The CBK usable foreign exchange reserves remained adequate at USD 9,175 million (5.6 months of import cover) as at August 20. This meets the CBK's statutory requirement to endeavour to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (Table 2).

Money Markets

The money market remained liquid during the week ending August 20, supported by government payments, which offset tax receipts. Commercial banks' excess reserves stood at KSh 14.2 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 2.58 percent on August 20 compared to 1.76 percent on August 13. The average number of interbank deals per day increased marginally to 21 from 20 in the previous week, while the value traded decreased to KSh 12.6 billion from KSh 14.5 billion in the previous week (Table 3).

Government Securities Market

The Treasury bills auction of August 20 received bids totaling KSh 9.7 billion against an advertised amount of KSh 24.0 billion, representing a performance of 40.4 percent. Interest rates on the 91-day and 182-day Treasury bills increased marginally while the rate on the 364-day Treasury bill decreased (Table 4).

The 11-year Infrastructure Treasury bond of August 19 received bids totaling KSh 101.5 billion against an advertised amount of KSh 70.0 billion, representing a performance of 145.0 percent. The bond was sold at an average rate of 11.30 percent (Table 5).

Equity Market

At the Nairobi Securities Exchange, the NASI and NSE 25 share price index increased by 1.4 percent and 2.8 percent, respectively during the week ending August 20. Similarly, market capitalization, equity turnover and shares traded increased by 1.4 percent, 6.3 percent and 46.3 percent, respectively (Table 6).

Bond Market

Turnover of bonds traded in the domestic secondary market declined by 44.0 percent during the week ending August 20 (Table 6). In the international market, yields on Kenya's Eurobonds increased by an average of 5.7 basis points. The yields on the 10-year Eurobonds for Ghana and Angola also increased (Chart 2).

Global Trends

The US Fed minutes from the July meeting confirmed the continued dovish stance while maintaining aggressive measures to support the economy. Jobless claims in the US also rose above 1 million against expectations of 925,000, setting back growth expectations for the second half of the year.

International oil prices declined marginally during the week. Murban oil prices declined to USD 44.28 per barrel on August 20 from USD 44.41 per barrel on August 13.

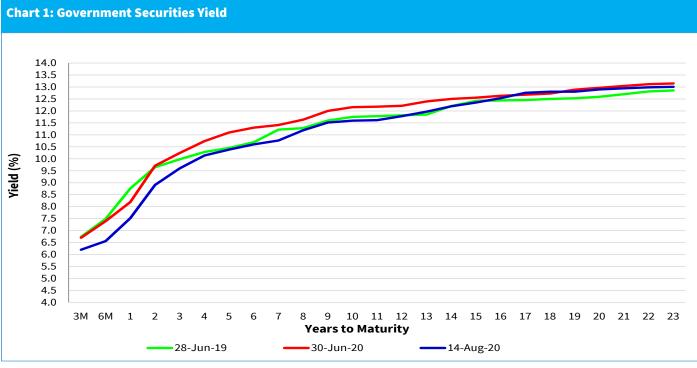

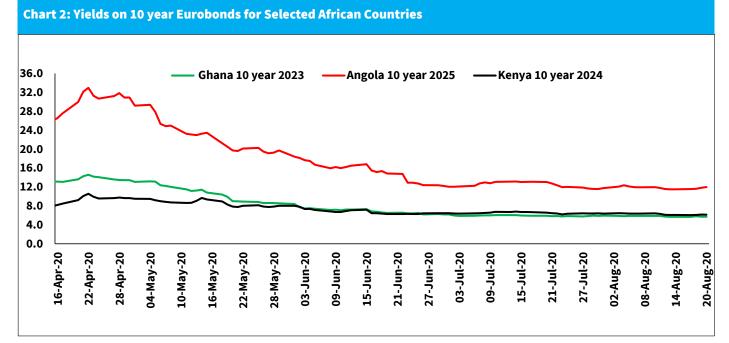
