



# RECENT MONETARY AND FINANCIAL DEVELOPMENTS

#### **Inflation**

Overall inflation declined to 9.5 percent in November 2022 from 9.6 percent in October due to easing food prices arising from seasonal factors and declining of international food prices. Food inflation declined to 15.4 percent from 15.8 percent in October. Fuel inflation increased to 13.8 percent from 11.7 percent in October, while Non-food-non-fuel (NFNF) inflation increased to 4.2 percent from 3.8 percent in October (Chart 1).

### **Current Account**

Provisional data on balance of payments shows that the current account deficit was estimated at 5.5 percent of GDP in the 12 months to October 2022, from 5.2 percent in a similar period in October 2021 (**Chart 2**). The wider deficit reflects a higher import bill, particularly for oil, which more than offset increased receipts from tea and services exports, and remittances.

### **Exchange Rates**

The Kenya Shilling remained stable against major international and regional currencies during the week ending December 1. It exchanged at KSh 122.50 per US dollar on December 1, compared to KSh 122.23 per US dollar on November 24 (**Table 1**).

### **Foreign Exchange Reserves**

The usable foreign exchange reserves remained adequate at USD 7,070 million (3.96 months of import cover) as at December 1. This meets the CBK's statutory requirement to endeavor to maintain at least 4 months of import cover (Table 2).

# **Money Market**

Liquidity in the money market increased during the week ending December 1, as government payments more than offset tax remittances. Commercial banks' excess reserves stood at KSh 13.0 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 5.08 percent on December 1 compared to 4.83 percent on November 24. During the week, the average number of interbank deals increased to 33 from 29 in the previous week, while the average value traded increased to KSh 22.1 billion from KSh 21.5 billion in the previous week (Table 3).

### **Government Securities Market**

The Treasury bill auction of December 1, received bids totaling KSh 19.8 billion against an advertised amount of KSh 24.0 billion, representing a performance of 82.4 percent. Interest rates remained stable, with 91-day, 182-day and 364-day Treasury bill rates increasing marginally **(Table 4)**.

During the Treasury bond auction of December 1, the 6-year switch infrastructure bond issued received bids totaling KSh 52.9 billion against an advertised amount of KSh 87.8 billion, representing a performance rate of 60.3 percent **(Table 5).** 

# **Equity Market**

At the Nairobi Securities Exchange, the NASI, NSE 25 and NSE 20 Share indices declined by 0.5 percent, 0.1 percent and 0.2 percent, respectively, during the week ending December 1. Market capitalization, equity turnover and total shares traded also declined by 0.5 percent, 32.0 percent and 37.5 percent, respectively (**Table 6**).


#### **Bonds Market**

Bond turnover in the domestic secondary market declined by 18.4 percent during the week ending December 1 (**Table 6**). In the international market, yields on Kenya's Eurobonds declined by an average of 67.6 basis points, with 2024 maturity declining by 126.4 basis points. The yield on the 10-Year Eurobond for Ghana rose while that of Angola declined (**Chart 4**).

### **Global Trends**

Concerns about inflation remained during the week ending December 1. The Euro Area inflation rate eased slightly in November to 10.0 percent from 10.6 percent in October. The US economy expanded by 2.9 percent in the third quarter of 2022 from a contraction of 0.6 percent in the previous quarter. The index of the US dollar against a basket of major currencies weakened by 1.0 percent during the week ending December 1.

International oil prices increased during the week ending December 1. Murban oil price rose to USD 85.86 per barrel on December 1 from USD 84.23 per barrel on November 24.








