

# KEY MONETARY AND FINANCIAL INDICATORS

## **Exchange Rate**

The Kenya Shilling strengthened against major international and regional currencies during the week ending December 5, boosted by inflows from corporates. It exchanged at KSh 101.96 per US Dollar on December 5 compared to KSh 102.54 on November 28. (Table 1).

## **Foreign Exchange Reserves**

The CBK usable foreign exchange reserves remained adequate at USD 8,752 million (5.43 months of import cover) as at December 5. This meets the CBK's statutory requirement to endeavour to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (Table 2).

#### **Current Account**

Preliminary data shows that the current account deficit narrowed to 4.1 percent of GDP in the 12 months to October 2019 from 5.0 percent in December 2018. This reflects slower growth of imports, resilient diaspora remittances and strong receipts from service exports (Chart 1).

## **Money Market**

The money market was liquid during the week ending December 5, partly due to Government end of month payments which offset tax receipts. The open market operations remained active. The average Commercial banks' excess reserves stood at KSh 10.6 billion in relation to the 5.25 percent cash reserves requirement (CRR). The average interbank rate increased to 6.52 percent on December 5 from 5.05 percent on November 28. The average number of interbank deals per day remained relatively stable at 30 compared to 29 in the previous week. The value traded remained high at KSh 22.4 billion compared to KSh 24.4 in the previous week (Table 3).

#### **Government Securities Market**

The Treasury bills auctions of December 5 received bids totalling KSh 13.3 billion against an advertised amount of KSh 24.0 billion, representing a performance of 55.3 percent. Interest rates on all the tenors remained stable compared to the previous auction (Table 4).

#### **Equity Market**

The NSE 25 Share price index, NSE 20, NASI and market capitalization increased by 1.7 percent, 0.2 percent, 1.5 percent and 1.5 percent, respectively. Similarly, total shares traded, equity turnover and the number of deals increased by 48.0 percent, 15.4 percent and 20.9 percent, respectively (Table 6).

#### **Bond Market**

Turnover of bonds traded in the domestic secondary market decreased by 54.6 percent during the week ending December 5 (Table 6). In the international market, yields on Kenya's 7-year, 10-year (2024), 10-year (2028), 12-year (2032) and 30-year (2048) Eurobonds increased by 12.7, 8.5, 9.6, 15.8 and 8.2 basis points, respectively. The yields on the 10-year Eurobonds for Ghana and Angola also increased (Chart 3).

#### **Global Trends**

Global markets continue to be driven by shifts in sentiment around US-China trade negotiations, and, subdued global growth. In the UK, the latest opinion polls on the December General Election show the Conservative party in the lead, which implies the likely continuation of efforts to get a Brexit deal.

International oil prices edged down during the week ending December 5. The Murban oil prices declined to USD 65.27 per barrel on December 5 from USD 65.73 per barrel on November 28.






