# RECENT MONETARY AND FINANCIAL DEVELOPMENTS

#### **Inflation**

Overall inflation remained stable in October 2023 mainly supported by easing prices of key food items. It stood at 6.9 percent compared to 6.8 percent in September. Food inflation declined marginally to 7.8 percent from 7.9 percent in September, supported by declining prices of fresh vegetables and key non vegetable items. However, fuel inflation increased to 14.8 percent in October from 13.1 percent in September, driven by higher energy prices. Non-food-non-fuel (NFNF) inflation declined to 3.6 percent from 3.7 percent in September, reflecting muted demand pressures (Chart 1).

### **Exchange Rates**

The Kenya Shilling remained relatively stable against major international and regional currencies during the week ending November 2. It exchanged at KSh 150.86 per US dollar on November 2, compared to KSh 150.27 per US dollar on October 26 **(Table 1).** 

# **Foreign Exchange Reserves**

The usable foreign exchange reserves remained adequate at USD 6,814 million (3.7 months of import cover) as at November 2. This meets the CBK's statutory requirement to endeavor to maintain at least 4 months of import cover (Table 2).

### **Money Market**

Liquidity in the money market decreased during the week ending November 2. Commercial banks' excess reserves stood at KSh 17.8 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 12.18 percent on November 2 compared to 12.51 percent on October 26. During the week, the average number of interbank deals decreased marginally to 23 from 24 in the previous week, while the average value traded decreased to KSh 13.5 billion from KSh 14.5 billion in the previous week (Table 3).

## **Government Securities Market**

The Treasury bills auction of November 2 received bids totaling KSh 24.7 billion against an advertised amount

of KSh 24.0 billion, representing a performance of 102.8 percent. Interest rates remained stable, with the 91-day, 182-day and 364-day rates increasing marginally (**Table 4**).

# **Equity Market**

At the Nairobi Securities Exchange, the NASI, NSE 25 and NSE 20 share price indices declined by 2.9 percent, 3.3 percent and 1.4 percent, respectively, during the week ending November 2. Market capitalization also declined by 2.9 percent, while equity turnover and total shares traded increased by 143.4 percent and 167.0 percent, respectively (Table 6).


#### **Bond Market**

Bond turnover in the domestic secondary market increased by 2.6 percent during the week ending November 2 (**Table 6**). In the international market, yields on Kenya's Eurobonds declined by an average of 89.18 basis points, with the 2024 maturity declining by 111.50 basis points. The yields on the 10- Year Eurobonds for Zambia and Angola also declined (**Chart 3**).

# **Global Trends**

Inflation concerns in advanced economies continue to moderate, with inflation in the Eurozone falling to 2.9 percent in October from 4.3 percent in September. The US Federal Reserve held benchmark interest rates steady in a target range of 5.25% - 5.5%, where it has been since July. The US dollar index weakened by 0.48 percent against a basket of major currencies during the week ending November 2.

International oil prices declined during the week ending November 2, due to the disspating impact of the war between Israel and Palestine. Murban oil price declined to USD 87.24 per barrel on November 2 from USD 90.23 per barrel on October 26.




