

# **KEY MONETARY AND FINANCIAL INDICATORS (REVISED)**

### **Exchange Rates**

The Kenya Shilling strengthened against major international and regional currencies during the week ending August 27. It exchanged at KSh 108.15 per US dollar on August 27, compared to KSh 108.56 per US dollar on August 20 (Table 1).

# **Foreign Exchange Reserves**

The CBK usable foreign exchange reserves remained adequate at USD 8,963 million (5.4 months of import cover) as at August 27. This meets the CBK's statutory requirement to endeavour to maintain at least 4 months of import cover, and the EAC region's convergence criteria of 4.5 months of import cover (Table 2).

#### **Remittances**

Remittance inflows remained strong in July 2020 amounting to USD 277.0 million compared to USD 225 million in July 2019 and USD 288.5 million in June 2020, in line with seasonal factors (Chart 1). The cumulative inflows in the 12 months to July totalled USD 2,862 million compared to USD 2,778 million in the 12 months to July 2019, an increase of 3.0 percent. Remittances in the seven months to July 2020 were 3.9 percent higher than in the same period in 2019. Inflows from the United Kingdom, Saudi Arabia, Qatar and Germany increased, while those from the US and South Africa decreased slightly compared to June.

### **Current Account**

Provisional data on balance of payments shows that the current account deficit narrowed to 4.7 percent of GDP in the 12 months to July 2020 compared to 5.0 percent of GDP in the 12 months to June (Chart 2). This reflected lower oil imports and improvement in tea exports and remittance receipts.

## **Money Markets**

The money market was relatively liquid during the week ending August 27, supported by government payments, which partly offset receipts from tax and issuance of government securities. Commercial banks' excess reserves stood at KSh 28.7 billion in relation to the 4.25 percent cash reserves requirement (CRR). Open market operations remained active. The average interbank rate was 3.01 percent on August 27 compared to 2.58 percent on August 20. The average number of interbank deals

per day increased to 27 from 21 in the previous week, and the value traded increased to KSh 16.7 billion from KSh 12.6 billion in the previous week (Table 3).

### **Government Securities Market**

The Treasury bills auction of August 27 received bids totalling KSh 12.6 billion against an advertised amount of KSh 24.0 billion, representing a performance of 52.3 percent. Interest rates remained stable, with the rates on the 91-day and 182-day Treasury bills rising marginally and the rate on the 364-day Treasury bill remaining virtually the same (Table 4).

## **Equity Market**

At the Nairobi Securities Exchange, the NASI, NSE 25 and NSE 20 share price indices rose by 4.3 percent, 4.8 percent and 2.1 percent, respectively during the week ending August 27. Similarly, the number of shares traded, equity turnover and market capitalization increased by 37.2 percent, 71.9 percent and 4.4 percent respectively (Table 6).

### **Bond Market**

Turnover of bonds traded in the domestic secondary market rose by 146.7 percent during the week ending August 27 (Table 6). In the international market, yields on Kenya's Eurobonds declined by an average of 12.4 basis points. The yields on the 10-year Eurobonds for Ghana and Angola also declined (Chart 4).

#### **Global Trends**

Global financial markets sentiment was buoyed during the week by the continued optimism on Coronavirus vaccine, news of release of cooperative statements on Phase 1 of the US-China trade deal, better than expected US economic data, and extension of Covid-19 stimulus measures by Germany to December 2021. However, the European equity market remained cautious as investors digested a policy shift by the Fed to put more weight on revamping the US labour market in addition to its inflation and employment mandate.

International oil prices increased during the week. Murban oil price increased to USD 45.57 per barrel on August 27 from USD 44.28 per barrel on August 20.


