### **Activity in the Interbank Market**

The volumes traded in the interbank market increased to an average of KSh 16.8 billion during the week ending March 14, 2018, from KSh 13.5 billion the previous week, partly attributed to remittance of PAYE taxes. The number of deals in the interbank market remained relatively stable at an average of 32. The weighted average interbank rate eased to 4.32 percent from 4.72 percent in the previous week due to large banks that dominated the market borrowing at low rates (**Table 1**).

## Kenya Shilling Exchange Rate

The Kenya Shilling exchange rate remained steady against major international currencies during the week ending March 15, 2018. The Shilling strengthened against the US Dollar, the Euro and the Japanese Yen, but weakened against the Sterling Pound. In the EAC region, the Kenya Shilling weakened against all the currencies (Table 2).

#### **Equity Market**

The equity market recorded gains in the week ending March 2018. The NASI, NSE 25 and the NSE share indices increased by 0.9 percent, 2.2 percent and 1.3 percent, respectively, while equity turnover increased by 0.5 percent. As a result, shareholder wealth as measured by market capitalization increased slightly by KSh 23.8 billion or 0.9 percent (Table 3).

#### **Bond Market and Eurobond Yields**

Turnover in the bond market increased by 57.0 percent in the week ending March 15, 2018, compared to the previous week, as investors increased fixed income investment in the secondary market.

The yields on Kenya's 5- year, 10-year and 30 year

Eurobonds, declined marginally during the week, signalling an increase in bond prices (Table 3).


